

**RESOLUTION NO. 2021-0813-3**

**EAST SHORE CONSERVANCY DISTRICT**

**RULES AND REGULATION CONCERNING PUMP, AND LATERAL INSTALLATION  
REPLACEMENT AND RELOCATION**

WHEREAS, the East Shore Conservancy ESCD ("ESCD") has acquired, engineered, constructed, and maintains a low pressure sewage disposal system to serve the ESCD's freeholders; and

WHEREAS, the Board of ESCD is advised that all freeholders currently connected to the ESCD system utilize the 2HPZOGP Series Grinder – 240ov/1ph, grinder pump as recommended by the design engineer for the efficient operations of the ESCD's sewage disposal system; and

WHEREAS, in anticipation of the addition of new users to the ESCD system, and due to the remodeling, additions to existing structures, new homes or structures being built, and existing grinder pumps being relocated, destroyed or replaced, the District's engineer advises it is critical that reliability and consistency in the ESCD's system be maintained; and

WHEREAS, after consulting with the ESCD's engineer, the Board of the ESCD has determined that in the best interest of the ESCD's freeholders and customers and for the integrity of the ESCD's system, all installations and replacements of laterals and grinder pumps shall be in conformity with this Resolution.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF THE  
EAST SHORE CONSERVANCY DISTRICT:**

## **Section 1— Purpose**

The purpose and objective of this Resolution is to ensure that the integrity and quality of the ESCD sewer facilities are maintained at the appropriate level which, among other things, allows the ESCD to maintain compliance with the wastewater treatment contract with the Town of Culver and all applicable statutes and regulations.

## **Section 2 — General Installation, Replacement and Relocation Requirements**

### **2.1 — General Requirements**

A. The owner of any home, or structure, whether for human occupancy, recreation or other purpose ("Facility") which may produce sewage or wastewater discharged through the owner's grinder station or stations into the ESCD's sewer facilities, shall be required at the owner's expense to purchase a 2HPZOGP Series Grinder – 240v/1ph grinder pump, install said grinder pump to receive all sewage produced from the facility and connect said grinder pump directly to the ESCD's sewer facilities all in accordance with the provisions of this Resolution and the ESCD's policies.

B. Any installation, replacement, alteration, relocation or modification of a grinder pump and/or lateral shall be made only by the vendor whom the ECSD has approved to provide such services.

C. Any time there is an installation, alteration, relocation or modification of a grinder pump or lateral that connects the pump to the ESCD's system, the owner of the Facility shall notify the ESCD in writing and shall obtain a permit and pay the inspection fee in effect at the time.

D. If an owner fails to (1) obtain a permit from the ESCD for new construction or relocation or modification of an approved grinder pump and/or lateral connection to the ESCD's system and (2) have the new construction or relocation or modification inspected and approved by the ESCD, the ESCD shall have the right and authority to disconnect the connection to the ESCD's system without notice to the owner until such time as the grinder pump, line and connection are uncovered by the owner at the owner's sole cost and expense and inspected by the ESCD to ensure all connections, laterals and grinders stations meet the ESCD's standards without any liability to the ESCD whatsoever.

E. No person shall make connection of any roof downspouts, exterior foundation drains, sump pump areaway drains, or other sources of surface runoff or groundwater to a sewer lateral or building drain, which in turn is connected directly or indirectly to the ESCD's sewer facilities. If any aforementioned connection is made the ESCD shall have the right and authority to disconnect the connection to the ESCD's system without notice and without any liability to the ESCD whatsoever.

F. Should any owner of a Facility desire to deviate from these provisions, written permission must be obtained from the ESCD.


This Resolution shall be in full force and effect as of the date of adoption hereof.




